### GOVERNANCE

#### Charitable Objectives

The objectives of Jewish Heritage UK are:

1. The preservation and conservation for the benefit of the public of historic buildings and sites of Britain's Jewish community
2. The promotion of the Jewish Heritage by educating the public in the subject of historic buildings and sites of Britain's Jewish community and facilitating public access to them

The Charity Commission's guidelines on public benefit are taken into account by the Trustees when planning the activities of the charity.

The organisation operates nationally, in England, Wales, Scotland and Northern Ireland. Where appropriate, Jewish Heritage assists in the protection of the material cultural heritage of the Jewish communities of the Channel Islands, the Isle of Man, the Irish Republic and Gibraltar, which have close historic ties with the Jewish community on the UK mainland.

Within the Jewish community, Jewish Heritage provides independent professional support to individual congregations, trustees and synagogue organisations that are responsible for historic buildings and sites. Jewish Heritage liaises with official conservation bodies, especially English Heritage, national Amenity Societies and Local Planning Authorities, on matters pertaining to historic synagogues and sites. This rôle is becoming increasingly important with changes to the Heritage Protection regime, despite the shelving during 2008 of the Heritage Protection Bill. However, in the longer term, statutory change cannot be ruled out on Listed Buildings and the "Ecclesiastical Exemption" currently enjoyed by Places of Worship of certain Christian denominations. Liberalisation of planning law, with implications for the status of designated historic sites and Conservation Areas, remains a matter of concern.

Since 2006 Jewish Heritage has been included under 'Useful Addresses' in the annual *Institute of Historic Building Conservation Handbook* - the essential resource guide in the Heritage sector. Jewish Heritage annually updates the now established 'List of Listed Synagogues, Former Synagogues and other Jewish Sites in the UK' in the *Jewish Year Book*. The electronic version on Jewish Heritage's website now allows for more frequent updating.

#### Charitable Status

Three years after the establishment of the organisation in February 2004, Jewish Heritage UK attained Registered Charity status on 1<sup>st</sup> March 2007 (Reg. Charity No. 1118174). The charity is governed by a Declaration of Trust dated 30 January 2007. New Trustees are elected at a Special Meeting by a majority vote of the Trustees. Jewish Heritage is a member of the National Council for Voluntary Organisations (NCVO).

All Jewish Heritage staff are self-employed, working freelance on a contract-for-services basis. They are responsible for their own tax and National Insurance contributions. ## ACHIEVEMENTS 2009

### National Collaborations

#### **English Heritage: Synagogues at Risk Survey**

In 2009 Jewish Heritage conducted a survey of all the Listed synagogues in England in the context of the larger English Heritage *Heritage at Risk* programme that includes Listed places of worship of other faiths, especially churches. The 'Synagogues at Risk' (SAR) Survey was commissioned by English Heritage in order to foster understanding of the specific needs of synagogues as a building type and to facilitate grant aid to congregations most in need, primarily through the English Heritage and Heritage Lottery Fund [EH/HLF] Joint Listed Places of Worship Repair Grant Scheme.

Through the SAR Survey, Jewish Heritage has sought to identify priority cases of 'Synagogues at Risk'. The level of 'risk' is determined by two major criteria: *Condition* and *Usage*. In the past, the condition of the actual fabric of a given building, especially its structural stability, roof coverings, high-level stonework, drainage, and overall maintenance, has largely determined a building's candidacy for the English Heritage Listed Buildings at Risk (BAR) Register. These are also the criteria that determine eligibility for grant aid under the EH/HLF Grant Scheme. However, it is now recognised that 'redundancy' can pose a threat to the survival of an historic building equal to that posed by the deterioration of its actual fabric, and that synagogues are particularly vulnerable in this regard.

Between March and June 2009 the Director and/or Consultant Architect visited 40 synagogues around the country. These comprised 34 Listed (purpose-built or housed in other converted Listed buildings); four unlisted but important synagogues and two Scottish synagogues. In September 2009 the Director made a separate visit to the Listed synagogues in Edinburgh and Glasgow.

A 20,000 word-report was compiled in July 2009 and submitted to English Heritage. Its findings will be published as part of the national 'Heritage at Risk: Places of Worship At Risk' campaign in the summer of 2010.

The Director attended the 2009 'Heritage at Risk: Conservation Areas' lunch and media event in London on Wednesday 24<sup>th</sup> June 2009.

The Director, together with Rabbi Geoffrey Shisler and Henry Magrill, hosted the All-Parliamentary Group on Historic Churches at New West End Synagogue on Tuesday 14<sup>th</sup> July 2009. A photograph taken with the Rt. Hon. Frank Dobson MP, co-chair of the group, appeared in the Jewish press.

The Director contributed an illustrated article entitled 'Historic synagogues: appreciation and challenges' to an issue of English Heritage's magazine *Conservation Bulletin* devoted to 'Places of Worship' that was published to coincide with the above events in summer 2009.

#### **SPAB 'Faith in Maintenance' Project**

The Director represents Jewish Heritage UK on the steering committee of 'Faith in Maintenance' (FiM), a Heritage Lottery Fund (HLF)-funded project initiated by the Society for the Protection of Ancient Buildings (SPAB, the senior conservation society in the country). The FiM project was set up to train volunteer custodians of all faiths to safeguard their historic places of worship.

Jewish Heritage worked in close collaboration with SPAB to organise the first FiM day course for the Jewish community. This very successful event took place on Sunday 18th October 2009 at the New West End Synagogue in London. It attracted 18 participants from historic synagogues all over the country, including London, Exeter, Liverpool and Glasgow. The course leader was Sara Crofts of SPAB who encouraged group discussions during her lively and practical presentations on building maintenance. These included a hands-on survey of the New West End Synagogue to train participants to spot potential problems with the building fabric (in 2010 the building is due to undergo £108,000 worth of repairs under the Joint Places of Worship Repair Grant Scheme). Other presentations were made by the Director of Jewish Heritage and Harvey Bolchover of the Community Security Trust.

#### ***English Heritage: Historic Places of Worship Support Officers Scheme***

At the end of December 2008 (see 2008 *Annual Report*) the Secretary of State for Culture, Media and Sport announced that English Heritage (EH) would be making available £1.5 million to part-fund 30 Support Officers to help congregations of all faiths manage and maintain their historic places of worship. In 2009 it was understood that the 'Synagogues at Risk Survey' would lead on to English Heritage support for Jewish Heritage' under the Scheme, mooted for 2010.

In spring 2009 Jewish Heritage made a successful bid to Rothschild Foundation Europe (RFE) for a renewal and increase in funding expressly to match-fund anticipated English Heritage funding under their Support Officers Scheme. The bid to English Heritage was successful in November and the contract was signed with a start date of April 2010. Jewish Heritage is very grateful to RFE for their continued generous support, and to English Heritage for once again backing our work. Both bodies supported the Survey of the Jewish Built Heritage in the UK & Ireland from the late 1990s and the publication of Sharman Kadish, *Jewish Heritage in England: An Architectural Guide* English Heritage, 2006 (see *Financial Review* below).

#### ***Heritage Open Days***

Jewish Heritage regularly promotes British Jewry's material heritage to the wider public through encouraging participation in both the annual national Heritage Open Days (HoDs) and European Jewish Heritage Day, organised by B'nai Brith, which since 2000 has become a popular annual event in the UK. These events are held every September.

In Manchester, HoDs are combined with the Cheetham Festival that celebrates cultural diversity in the Cheetham Hill area north of the city center, that for Manchester Jewry is the equivalent of the East End of London. Along with Jeremy Michelson, Education Officer at the Manchester Jewish Museum, Jewish Heritage Director Sharman Kadish was co-opted onto the Cheetham Festival Committee. This is chaired by Revd. Daniel Burton, Vicar of Cheetham, who is also a Trustee of the North West Multi-Faith Tourism Association.

In 2009, the Cheetham Festival brochure was again attractively produced in full colour by North Manchester Regeneration and supported by English Heritage North West Region and Manchester City Council. Jewish attractions, free entry to the Manchester Jewish Museum (originally negotiated by Jewish Heritage), the Cheetham Jewish Heritage Trail, and guided tour of Higher Crumpsall Synagogue (on the extremity of Cheetham Hill) were prominently promoted.

The Director participated in a live edition of BBC Greater Manchester Radio's Jewish programme on 7th September to help promote HoDs in both Manchester and Liverpool.

#### ***Other Organisations***

Jewish Heritage is represented on the nationwide Heritage Link and specifically on the Heritage Link Places of Worship Steering Group chaired by Crispin Truman of the Churches Conservation Trust. In November 2009 Dr Kadish was able to take up an invitation first made in 2008 to present a workshop at the Churches Tourism Association's annual convention held in Coventry.

The Director attended a meeting organised by the Heritage Lottery Fund and hosted by Carol Souter in Birmingham on 17<sup>th</sup> September.

##### Synagogue Closures/Threatened Closures/Alterations

In 2009 the Jewish Heritage Casework Committee was established and held its first meeting in November. Its deliberations benefit from data gathered by the Synagogues At Risk Survey. It was noted that the most pressing cases were now more likely to date from the early 20<sup>th</sup> century rather than the Victorian period, given the enhanced statutory protection bestowed on the best of these.

#### ***Tourism Development***

Jewish Heritage continues involvement in both *Heritage Open Days* and *European Jewish Heritage Day* (see above). During the former, the Director's annual tour of Manchester's Higher Crumpsall Synagogue attracted 17 people. This synagogue celebrated its 80<sup>th</sup> Anniversary in 2009.

*Heritage Trails* in the East End of London, Manchester, Birmingham and Brighton published in Sharman Kadish *Jewish Heritage in England: An Architectural Guide* (English Heritage 2006) have resulted in increased visitor numbers to sites en route.

The Director gave a presentation at the annual Churches Tourism Association conference in Coventry in November 2009.

#### **Education and Dissemination**

The Director contributed an article on synagogues to the summer 2009 edition of English Heritage's *Conservation Bulletin* devoted to places of worship. She provided articles for the Jewish New Year issues of synagogue magazines for Liverpool, Princes Road and Bradford synagogues (September 2009).

In the winter of 2009-10 the Director finished work on the manuscript of her new book *The Synagogues of Britain and Ireland: An Architectural and Social History*. It is due to be published by Yale University Press in spring 2011, with 250 illustrations, many of which were taken by English Heritage.

#### **Website**

During 2009 the website continued to be updated and gradually expanded. The number of users has been increasing, currently standing at around 1,000 visitors per month. This growth is reflected in an increasing volume of enquiries, mainly via email, from the UK and overseas.

The website is linked to a sister project, [www.jewish-heritage-europe.eu/](http://www.jewish-heritage-europe.eu/) Further development of both sites is planned.

#### **FINANCIAL REVIEW**

By the end of the calendar year residual funds had been used up from the original £75,000 grant given for the establishment of Jewish Heritage in 2004. This grant pre-dated the achievement of charitable status and was administered on our behalf by the London Jewish Cultural Centre (LJCC Registered Charity No. 1081014). In December 2009 the LJCC account was closed. The Trustees would like to thank the LJCC and in particular their accountant, Mr David Horowitz, for the meticulous manner in which the accounts have been administered over the past five years.

During 2009 grant aid for the following three years was secured. The grant from RFE is worth £90,900 over three years, beginning from September 2009. The matching grant from English Heritage totals £90,840 over three years starting from April 2010.

At their next meeting, the Trustees will adopt a reserves policy for the charity.

Over the next three years efforts will be made to widen the donor base of Jewish Heritage UK. Plans are under consideration to establish the charity as a membership organisation.

**1 Accounting policies**

The principal accounting policies adopted in the preparation of the financial statements are set out below. They have been applied consistently during the year, and in the preceding year.

**a Basis of preparation**

The financial statements have been prepared under the historical cost convention and in accordance with the Charities Act 1993, the Statement of Recommended Practice - Accounting and Reporting by Charities (issued in March 2005), and the Financial Reporting Standard for Smaller Entities (effective April 2008).

**b Fund accounting**

- Unrestricted funds are available for use at the discretion of the trustees in furtherance of the general objectives of the charity.
- Restricted funds are subjected to restrictions on their expenditure imposed by the donor or through the terms of an appeal.

**c Incoming resources**

All incoming resources are included in the Statement of Financial Activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

- Voluntary income is received by way of grants, donations and gifts and is included in full in the Statement of Financial Activities when receivable. Grants, where entitlement is not conditional on the delivery of a specific performance by the charity, are recognised when the charity becomes unconditionally entitled to the grant.
- Investment income is included when receivable.
- Incoming resources from charitable trading activity are accounted for when earned.
- Incoming resources from grants, where related to performance and specific deliverables, are accounted for as the charity earns the right to consideration by its performance.

**d Resources expended**

Expenditure is recognised on an accrual basis when a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is included as part of the expenditure to which it relates.

**e Cash flow statement**

The charity has taken advantage of the exemption in Financial Reporting Standard 1 from preparing a Cash Flow Statement on the grounds that it is a small entity.
